Electric shock	Medium/Low	Disconnect machine when not in use. Check power chord for damage and safe placement prior to use. Never use machine in wet or damp conditions. Do not use machine when abnormal power conditions occur. Where extension leads are required – minimum wire diameter permitted – 1.0mm² up to 25m length and 1.5mm² up to 35m length.		
Contact with moving parts	Medium/Low	Do not bend short lengths (<30cm). Keep body parts well clear of moving parts when operating machine. In particular, ensure hands are well clear of bending module/pin whilst operating machine. Always wear protective gloves when handling machine.

Contact with hot parts of the machine body	Medium/Low	Do not touch pump housing after us, always allow time to cool. Always wear protective gloves when handling machine.
Instability	Medium/Low	Hold bender firmly and maintain proper footing and balance. Do not use at heights. Machine could move during operation.
Exposure to ultraviolet radiation while working outdoors	Medium	Wear appropriate PPC to cover exposed skin and sunscreen
